Funds from ACH credits will ordinarily be available within one (1) business day of the check date. Credit due on a non-business day will be received the next business day. By choosing ACH payment, you will no longer receive your revenue check detail by mail. 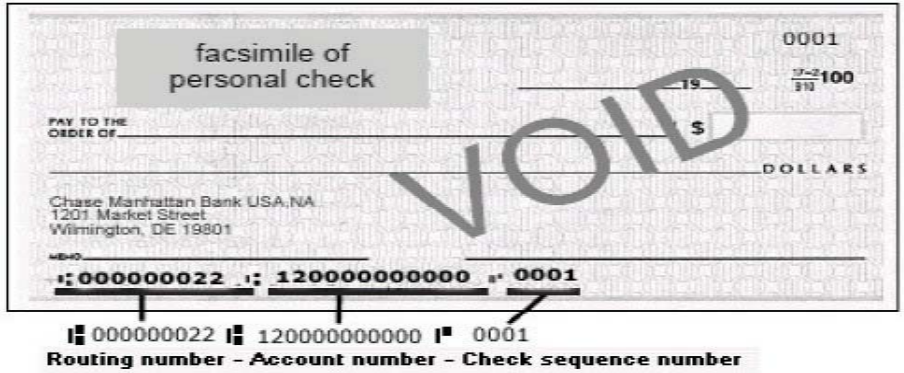
